Introduction


At Kilroy Realty Corporation, we recognize that much of the environmental footprint of our operations lies in our supply chain. This spans all of the services and products we procure to construct and operate our buildings and the services and products that those suppliers in turn procure. This report is our second annual report providing us insight into environmental, social and governance (ESG) impacts in our supply chain.

Last year, we surveyed our Critical Tier 1 operational suppliers, those for whom a disruption would immediately impact our day-to-day operations. We determined that our Engineering, Janitorial, Security, Landscaping and Parking suppliers fall into this Critical Tier 1 category. We sent our Supplier Survey to all critical Tier 1 suppliers in 2019 and analyzed and published the results, the first time a North American REIT had done so.

This year, we expanded this work into our development activities. We identified our Critical Tier 1 development suppliers as our Architects, Engineers and General Contractors. We then surveyed these suppliers on their ESG practices, and those results are contained in this report. Each critical Tier 1 supplier has been given a personalized report of these results with specific recommendations for improvement, and in this way we hope to influence environmental and social outcomes in our supply






Does your company have an Environmental Sustainability program?




Does your company monitor greenhouse gas emissions?




Does your company monitor water usage?




Does your company monitor renewable energy usage?






Has your company set energy reduction targets?




Does your company monitor waste and where it goes?






Has your company set targets around reducing landfill waste?








Is your company's EMS registered/accredited to a system standard such as ISO 14001?




Does your company monitor compliance with local environmental regulations?




Does the Environmental Management System monitor compliance to local environmental regulations?




Has your company set greenhouse gas emissions targets?


What is your company's % of suppliers that publicly support respecting human rights as defined by the United Nations Universal Declaration of Human Rights?







Does your company publicly support respecting human rights as defined by the United Nations Universal Declaration of Human Rights?




Does your company have a publicly stated Business Ethics and Code of Conduct?






Does your company retain master copies on file as a quality record?




In the past year has your company had quality issues?




Does your company have a grievance mechanism to allow stakeholders to communicate issues with the company?



In the past year has your company had products or services disruptions?




Does your company evaluate/measure customer satisfaction?


