- Creating clear and concise presentations and overviews directed towards senior management and Investment Committee with supervision of SVP, Investments
- Monitoring market transactions for both leasing and capital markets
- Develop and maintain a deep network of market participants in order to assist the Company in the sourcing of opportunities
- Reviewing and summarizing acquisition diligence materials



- Work with Kilroy's leasing and asset management teams to analyze strategic decisions including leasing analysis, return on capital investment evaluation, and other portfolio management analysis to assist in the decision-making process
- Evaluating, through Argus, NPV and IRR analyses, the financial impact of lease proposals, terminations, and renewals for active and pipeline development projects
- Assist FP&A and Corporate Finance teams in the preparation of internal and external investor relations materials
